Our highly-trained staff is committed to helping by providing education, support and honest feedback. CHD is certified by the State of Oregon Office of Alcohol and Drug Abuse Programs. We have offered mental health and addiction treatment services to Union County residents for over 20 years.

Specific providers at CHD are contracted with Regence Blue Cross Blue Shield of Oregon as preferred providers for behavioral health services. Please check the Regence website or ask Intake Staff for details. We are able to bill most other insurance plans, and we provide services through contracts with many Employee Assistance Programs.

CHD is dependent on client fees to pay for the costs associated with treatment. However, no one will be denied clinical services because of an inability to pay. We do have funds available to assist a limited number of clients with the cost of treatment, based on clinical need, family size, and household income. SERVICES OFFERED

DUII Rehab

CDL Department of Transportation Violation Evaluations

CHD has certified Substance Abuse Professional (SAP) staff with in-depth knowledge of the Department of Transportation rules and regulations governing drug and alcohol testing for Commercial Driver's Licenses (CDL). Services include:

- Comprehensive assessment and clinical evaluation.

- Recommendation and referral to education and treatment resources.
- Follow-up evaluation.
- Documentation to employer concerning recommended program, confirmation of completion, and recommendations for urinalysis testing.
- Services administered according to current DOT 49 CFR Part 40 Procedures.

Outpatient Treatment

CHD outpatient treatment programs are designed for individuals who have a substance abuse problem that needs moderate intervention to obtain sobriety. This can be achieved by:

- Individual & group sessions.
- Family component strongly encouraged.
- Relapse prevention groups.
- Individualized treatment planning to best meet your needs.
- Treatment groups at a variety of times to fit your schedule.

Intensive Outpatient

CHD intensive outpatient treatment programs are for those individuals who have a substance dependency problem who need a greater number of contacts per week than are provided by traditional outpatient services. These services include:

- Matrix evidence-based model.
- Early recovery relapse prevention.

- Family Education.
- Individualized treatment planning to best meet your needs.



Women in Treatment

We are proud to offer individualized treatment planning that specifically addresses the needs of women entering alcohol and drug treatment.

We offer individual counseling along with specialized therapy groups:

Seeking Safety addresses trauma and substance abuse. Some women have said of Seeking Safety, "This was the missing link for me."

Intensive Outpatient Groups start with Early Recovery Skills, Family Education and continue with Relapse Prevention.
